MADE BY THE MINISTER UNDER SECTIONS 15 AND 23 OF THE ANIMALS
(DISEASES, IMPORTATION, HEALTH AND WELFARE) ACT AND SUBJECT
TO NEGATIVE RESOLUTION OF PARLIAMENTTHE ANIMALS (IMPORTATION) CONTROL (AMENDMENT)
REGULATIONS, 2025

1. These Regulations may be cited as the Animals (Importation) Citation
Control (Amendment) Regulations, 2025.

2. These Regulations come into effect on the 1st day of January, Commencement
2026.

3. In these Regulations, “the Regulations” means the Animals Interpretation
(Importation) Control Regulations. Chap. 67:02

4. The Regulations are amended by revoking the Tenth Schedule Tenth
