ORDER

MADE BY THE MINISTER UNDER SECTION 88D OF THE MOTOR VEHICLES
AND ROAD TRAFFIC ACT AND SUBJECT TO NEGATIVE RESOLUTION OF
PARLIAMENT

THE MOTOR VEHICLES AND ROAD TRAFFIC (FIXED
PENALTY PAYMENT METHOD AND PAYEE) ORDER, 2026

1. This Order may be cited as the Motor Vehicles and Road Traffic Citation
(Fixed Penalty Payment Method and Payee) Order, 2026.

2. In this Order—

Interpretation

“fixed penalty” means the penalty prescribed under section 84 of
the Act;

“platform” means an online digital payment platform used to
facilitate payment of a fixed penalty; and

“voucher system” means a system which uses a prepaid or other
payment instrument with monetary value to facilitate payment
of a fixed penalty on the platform.

3. A fixed penalty may be paid—

Method of
payment of
fixed penalty

(a) in cash;

(b) by electronic means;

(c) *via* electronic form or by electronic means through a platform; or

(d) through a voucher system.

4. (1) For the purposes of section 88D(1)(e) of the Act, the following
are approved as payees for the payment of a fixed penalty:

Approval as
payee

(a) the Trinidad and Tobago Postal Corporation; and

(b) the Licensing Authority.

(2) Payment of a fixed penalty shall be made—

(a) where the payee is the Trinidad and Tobago Postal Corporation,
at any corporate shop specified in Schedule 1; or

(b) where the payee is the Licensing Authority at any office of the Licensing Authority specified in Schedule 2, or on the designated website within the control of the Licensing Authority.
